Sam Auld litigates antitrust and other complex cases before state and federal courts. He also represents a wide variety of clients in appeals and advises clients on other commercial litigation and regulatory and constitutional issues.

In recognition of his work, Mr. Auld was named one of *Best Lawyers' 2024 Ones To Watch in America*. He also was listed among Lex Machina's top 10 most active antitrust attorneys in the country from 2021-23.

Among others, Mr. Auld has represented:

- Caesars Entertainment, Inc. in class actions alleging that casino-hotels engaged in price-fixing through the use of pricing algorithms provided by revenue management software. Mr. Auld helped secure a groundbreaking dismissal of a complaint with prejudice against Caesars and other defendants
- Greystar in antitrust class actions and actions by state attorneys general alleging that multi-family property managers inflated rents through the use of revenue management software

Mr. Auld's appellate representations include:

- helping secure an *en banc* victory before the Eleventh Circuit, which ordered the district court to dismiss the plaintiff's Fair Debt Collection Practices Act claim for lack of Article III standing
- Equitable Life Insurance in an appeal that presented novel issues under the Federal Rules of Appellate Procedure
- business organizations and trade associations as *amici* before appellate courts across the U.S.
