She is also a planner of Pando, a national *pro bono* leadership summit that brings together leaders across the legal profession to advance collaboration and innovation in *pro bono* practice.

Ms. DeVaney frequently speaks at national and international events that focus on *pro bono* leadership, access to justice and law firm-corporate partnerships. She also serves as an adjunct professor at University of Michigan Law School and Northwestern Pritzker School of Law.

Earlier in her career, Ms. DeVaney was a member of the firm's Government Enforcement and White Collar Crime Group, where she represented individual and corporate clients in federal and state criminal and regulatory matters and conducted internal investigations.

Ms. DeVaney has been recognized for her service by organizations such as the New York City Bar Justice Center, Volunteer Lawyers for the Arts, the Legal Aid Society, Sanctuary for Families and the New York Family Court Volunteer Attorney Program.
