In addition to counseling clients on these issues as a member of Skadden’s Civil Rights Law Advisory Group — which advises private sector entities, educational institutions and nonprofits on complying with civil rights laws, preventing illegal discrimination and promoting fairness and equality in opportunities within their organizations — Ms. Flath regularly writes and speaks on these topics.
