He was an inaugural member of Skadden's Immigration Impact Project, which, since 2017, has recruited over 900 attorneys to represent over 600 immigrant clients. Mr. Guadarrama also maintains close ties with local nonprofit organizations, and currently serves on the board of directors of Ayuda, which provides legal, social and language services to low-income immigrants in the District of Columbia, Virginia and Maryland.

Mr. Guadarrama also works to heighten awareness of physical and mental disabilities in the legal profession. He has served as commissioner of the American Bar Association Commission on Lawyer Assistance Programs since 2021, in addition to serving as chair of its Diversity, Equity & Inclusion Committee. He also routinely volunteers with the D.C. Bar's Lawyers Assistance Program, which offers confidential counseling for lawyers facing mental health challenges. In 2020, he joined the Lawyers Depression Project, a group of legal professionals working to break the stigma around attorney mental health. As part of this initiative, he facilitates bimonthly online peer-to-peer support group meetings that offer members the option of anonymity.
