His arbitration experience includes representing one of the world's largest banks in an international arbitration involving political risk insurance and reinsurance; an international energy provider in connection with nuclear fuel rod losses; a transportation insurer in a reinsurance dispute concerning claims handling; and a leading life insurance company in a dispute against its reinsurer.

Mr. Luneau has been heavily involved in all aspects of international Bermuda Form insurance arbitrations on behalf of clients involving a wide array of issues. Such matters have involved the expected or intended defense and maintenance deductible, propriety and scope of the notice of (integrated) occurrence, streamlining discovery, allocation and apportionment of losses between covered and uncovered components. In addition, he has handled matters involving the reasonableness of the underlying defense efforts and settlements, the known loss or occurrence defense, retroactive coverage and efforts to rescind or void a policy in its entirety based on alleged misrepresentations in the insurance application.

Mr. Luneau also provides insurance-related advice to *pro bono* clients, lectures on various insurance matters and serves as a contributing editor for the New York State Bar Association's *Insurance Law Practice* book.
