Prior to joining Skadden, Mr. Michael served as the chief of the SEC Enforcement Division's Complex Financial Instruments Unit, where he oversaw a nationwide team of attorneys and market specialists in investigations and enforcement actions involving complex financial products and market practices.

At the SEC, he handled and supervised numerous matters concerning valuation, volatility, digital asset offerings, DeFi protocols, Regulation Best Interest and sales practices, security-based swaps, asset-backed securities and the SEC financial responsibility rules.

Mr. Michael has spoken and written extensively on SEC enforcement and white collar criminal matters and is the author of a quarterly column published by *Reuters* that focuses on regulatory issues relating to digital assets and blockchain technology.
