He also successfully tried a \$1.5 billion-plus excessive fee case against one of the world's largest asset managers brought under Section

36(b) of the Investment Company Act, which was one of the largest-ever cases involving claims against mutual funds. In addition, Mr. Musoff won summary judgment in favor of Merrill Lynch in what was termed a "landmark" case addressing the interpretation of credit default swap agreements with a monoline insurer. He also was a member of the team that represented Merrill Lynch before the United States Supreme Court in the first case in which the court addressed the provisions of the Securities Litigation Uniform Standards Act of 1998.

Additionally, Mr. Musoff has done a substantial amount of *pro bono* work. Among other successes, he won the largest known federal jury verdict in a housing discrimination case against a New York City cooperative. He also successfully defended against the enforcement of a German judgment in New York brought to recoup costs for repairs to a Berlin property that the client's family was forced to leave behind in escaping the Holocaust.

Mr. Musoff serves on the board of NYU Law School's Center on Civil Justice and the New York Legal Assistance Group, as well as having been appointed by New York's chief judge to the Permanent Commission on Access to Justice.
