Ms. Haffner maintains an active *pro bono* practice, including immigration, conservatorship and criminal matters. She submitted an amicus brief on behalf of the National Association of Federal Defenders to the U.S. Supreme Court on Fourth Amendment issues. Ms. Haffner also briefed, argued and won an appeal in the U.S. Court of Appeals for the Seventh Circuit. Most recently, she obtained favorable monetary settlements on behalf of families involved in immigration-related Federal Tort Claims Act cases. She also successfully obtained the release of a client who had been sentenced to life without parole and had spent over 38 years in prison after demonstrating that a *Brady* violation had occurred in the case.

Ms. Haffner is also on the board of the Western Center on Law and Poverty and on the Executive Committee of the Federal Bar Association for the Northern District of California.
