William E. Ridgway is co-head of Skadden’s global Cybersecurity and Data Privacy Practice. He is a former federal prosecutor with extensive trial and investigations experience who advises companies on their most sensitive cybersecurity, data privacy, artificial intelligence and white collar matters.

Mr. Ridgway has been recognized as a leading lawyer for crisis management, cybersecurity, data privacy, artificial intelligence and high-stakes white collar matters by several industry outlets. He regularly leads the defense of investigations conducted by the U.S. Department of Justice, the Securities and Exchange Commission, state attorneys general, the California Privacy Protection Agency and other U.S. and foreign regulators. These investigations frequently involve matters related to cybersecurity, data privacy, artificial intelligence, the False Claims Act, financial fraud and trade secret theft.

Mr. Ridgway has led the incident response and associated investigations for some of the most high-profile cybersecurity incidents in recent years, and his clients include financial institutions; technology, energy, insurance and health care companies; defense contractors; data brokers; and e-commerce retailers. He also often leads privacy and data security investigations and litigations around the country.

Mr. Ridgway’s experience includes:

- **Data breach and ransomware response** — advising *Fortune* 50 and other global companies in responding to ransomware attacks and other major cyber incidents
- **Government enforcement matters** — representing businesses, their boards and executives in government investigations and enforcement proceedings brought by a range of U.S. and foreign agencies and regulators
- **Data privacy, artificial intelligence and technology litigation** — defending companies in class action litigation related to cybersecurity incidents and in artificial intelligence and data privacy matters, which frequently involve complex and multijurisdictional issues
- **Internal investigations** — conducting sensitive, complex internal investigations, enabling companies to take strategic action to manage crises, avoid regulatory actions and limit legal and reputational exposure
- **Trials and arbitrations** — representing businesses and executives in high-stakes trials and arbitrations
- **Compliance and risk assessments** — conducting compliance and risk assessments on behalf of global firms, in addition to advising these clients on cybersecurity incidents, data privacy and artificial intelligence issues
- **Crisis incident simulation and training** — providing various crisis incident simulations and tabletop exercises for members of executive teams of international companies

Prior to joining Skadden, Mr. Ridgway was an assistant U.S. attorney in the U.S. Attorney's Office for the Northern District of Illinois, where he served as the deputy chief of the National Security and Cybercrimes Section. In this role, he oversaw and managed all of the office's cybercrime, data breach and intellectual property cases. During this time, Mr. Ridgway also held the positions of national security cyber specialist, computer hacking and intellectual property coordinator, and digital currency coordinator, handling cryptocurrency-related matters.

In his eight years as a federal prosecutor, Mr. Ridgway tried many cases and handled a wide range of high-profile cybercrime and intellectual property matters, including the prosecution of an international cybercrime ring responsible for stealing over \$100 million, as well as prosecutions of the leaders of two prominent hacking groups for hundreds of cyberattacks that targeted businesses, nonprofits and government bodies around the globe. Mr. Ridgway also led the prosecution of the operators of one of the world's largest online piracy rings.

Mr. Ridgway has received many awards and recognition throughout his career, including the Director's Award for Superior Performance from the Executive Office for United States Attorneys for prosecuting an international racketeering enterprise (2015) and the Chicago Crime Commission's Stars of Distinction Award for the prosecution of criminal enterprises operating in Chicago (2009 and 2010). In addition, he was selected as a Leadership Greater Chicago Fellow in its 2017 class.

Mr. Ridgway has been a lecturer at University of Chicago Law School since 2011, where he teaches a class on cybercrime.
