

She also played a significant role in drafting dispositive and trial motions in connection with a number of baby powder cases pending in state and federal court.

In addition, Ms. Rose has significant experience with respect to the defense of consumer class actions, having represented a variety of product manufacturers and consumer services providers facing proposed nationwide and statewide classes alleging consumer fraud, warranty and other claims. She has successfully defended clients such as Merck, GSK and the National Hockey League against class action allegations.

Ms. Rose also has substantial experience in successfully defending against challenges to her clients' claims of privilege and against allegations of spoliation of evidence in connection with product liability litigation. She advises corporate clients on best practices to protect the confidentiality of their privileged communications and to avoid costly discovery disputes regarding data retention.
