Before joining the firm in 2009, Mr. Scudder served in the White House as general counsel of the National Security Council under President George W. Bush from 2007-2009. Prior to that senior role, he provided legal advice on national security matters at the U.S. Department of Justice.

From 2002 to 2006, Mr. Scudder was an assistant U.S. attorney in the Southern District of New York, where he tried numerous cases and argued appeals in the U.S. Court of Appeals for the Second Circuit. He served as a clerk for U.S. Supreme Court Justice Anthony M. Kennedy and for Judge Paul V. Niemeyer of the U.S. Courts of Appeals for the Fourth Circuit. Prior to law school, Mr. Scudder worked in public accounting at Ernst & Young. He is a registered CPA in Illinois.

He also serves as a lecturer of law with Patrick Fitzgerald at the University of Chicago Law School on the subject of national security and criminal law, and as an adjunct professor in trial advocacy at the Northwestern University Pritzker School of Law.

Mr. Scudder actively participates in various *pro bono* activities, including participating in two jury trials and mentoring associates on their *pro bono* matters. In 2014, Mr. Scudder was recognized at the U.S. District Court's 15th Annual Awards for Excellence in Pro Bono and Public Interest Service for his contributions in helping people in need of assistance before the U.S. District Court for the Northern District of Illinois.
