He speaks publicly about the FCPA and the U.K. Bribery Act, and developments in anticorruption laws and their applications. His experience includes representing clients in all phases of litigation. Some of his representations have included:

- a major German pharmaceutical company and a German automaker in multinational anti-corruption investigations, including advising on compliance, diligence and internal audit matters;
- a foreign corporation on anti-bribery, anti-corruption and general compliance matters while under a monitorship and deferred prosecution agreement for FCPA violations;
