Previously, Mr. Vieira served on the boards of Genuity Science and Hakluyt & Co.

Prior to joining Sequoia, Mr. Vieira was a partner at Skadden, advising numerous technology companies, venture capital firms, private equity firms, defense contractors and other clients on matters related to congressional investigations, investment structures, regulatory enforcement, CFIUS, export controls, sanctions and cybersecurity.

Mr. Vieira also has extensive government experience, having previously served in senior positions in both the executive and legislative branches of the U.S. government, including chief of staff of the Department of Justice's (DOJ's) National Security Division (NSD) and counselor to the assistant attorney general for national security. At the DOJ, he supervised the department's work on hundreds of CFIUS reviews and advised on issues related to congressional oversight, cybersecurity, export controls, sanctions, counterterrorism, counterintelligence, telecommunications, information technology and electronic surveillance. He also testified before Congress as a DOJ representative and prepared senior officials, including the attorney general and others, for congressional testimony. He also prosecuted espionage cases and export and economic sanctions enforcement matters as a federal prosecutor in the DOJ's Counterespionage Section.

In addition, Mr. Vieira served as deputy chief counsel to the House Permanent Select Committee on Intelligence (HPSCI) and staff director of its Subcommittee on Oversight and Investigations, leading several classified committee investigations.
