At the DOJ, he supervised the department's work on hundreds of CFIUS reviews and advised on issues related to cybersecurity, export controls, sanctions, counterterrorism, counterintelligence, telecommunications, information technology and electronic surveillance.

Mr. Vieira served as deputy chief counsel to the House Permanent Select Committee on Intelligence (HPSCI) and staff director of its Subcommittee on Oversight and Investigations, leading several classified committee investigations. He also successfully prosecuted espionage cases and export and economic sanctions enforcement matters as a federal prosecutor in the DOJ's Counterespionage Section.

In addition, Mr. Vieira has experience as a corporate director, having served on the boards of Genuity Science and Hakluyt & Co.

Throughout his distinguished career, Mr. Vieira has received numerous awards and honors. While at Sequoia, he was repeatedly honored by *Washingtonian* as one of Washington, D.C.'s Tech Titans and Most Influential People.
